Modern Slavery And Human Trafficking Policy

Introduction

Modern slavery is a serious crime and a grave violation of fundamental human rights, depriving individuals of their freedom, dignity, and liberty for the profit or benefit of others. In line with the UK Modern Slavery Act 2015, Trustseal Ltd is committed to combating all forms of modern slavery and human trafficking in our operations and throughout our supply chain.

Our Commitment

We require our directors, employees, and stakeholders to take a zero-tolerance approach to modern slavery and human trafficking. We are fully committed to understanding modern slavery risks relevant to our business activities and taking all necessary steps to prevent any instances of slavery or human trafficking within our organisation or supply chain.

Scope

This policy applies to all employees, contractors, consultants, suppliers, and any third-party entities involved in our business. This policy will be reviewed and updated annually or as needed to ensure continued compliance with UK legislation and best practices.

Supplier Due Diligence

Supplier Standards

We require all suppliers to confirm compliance with the following:

- No use of forced, bonded, or involuntary labour.
- All work is voluntary, and employees have the freedom to terminate employment with reasonable notice.
- Each employee receives an employment contract, providing clear terms and reasonable notice for termination.
- Employees' wages are not withheld, and employees are not required to post bonds or deposits.
- No retention of passports, work permits, or other personal documentation as a condition of employment.

Awareness and Training

To raise awareness about modern slavery risks, we commit to the following:

- **Employee Education:** Providing training to employees at all levels to recognise signs of modern slavery and how to respond.
- **Supplier and Customer Engagement:** Distributing this policy to all suppliers and customers, outlining our anti-slavery standards and reporting requirements.
- **Induction Programs:** Including information about this policy in induction programs for new employees.

Measuring and Reporting

We assess the effectiveness of our efforts to combat modern slavery through the following indicators:

We will regularly review our practices and policies to strengthen our commitment and adapt to emerging risks or regulatory changes.
